To help us meet this goal, we partner with FACTS Management Company to administer our Monthly and Two-Payment tuition payments for the 2019-2020 school year. This partnership will provide significant benefits to families and school staff, including convenience, flexibility, and secure online access to individual account information.

### Your Payment Plan Options Through FACTS

Payments will be automatically deducted from a designated checking or savings account or automatically charged to a credit card (with 2.85 percent convenience fee added for credit card payments only) on your choice of the **5th or 20th** of the month. AMEX, MasterCard, Visa and Discover accepted.

#### Convenient Online Enrollment

#### Be sure to have the following information ready:

- Account information for the person responsible for payment: bank name, telephone number, account number, and the bank routing number. Most of this information is located on your check. If paying by credit card, have your card information available.
- Student ID number; if you do not have a Student ID number yet, you may submit the form without it and Brewster will enter it.

Before you click the **Submit** button, please carefully read the Final Review. Notification confirming your enrollment in a FACTS payment plan online will be sent to you after you submit your agreement.

### Frequently Asked Questions

- I. When and what times will the funds for my payment plan be withdrawn from my bank account? While FACTS transacts each payment on the specified date (e.g., 5<sup>th</sup> or 20<sup>th</sup> of the month), it is your financial institution that determines the time of day the payment is debited. FACTS recommends checking with your financial institution to determine how far in advance funds should be deposited into your account to ensure the automatic payment clears. If a payment date falls on a weekend or banking holiday, the payment will be transacted the following business day.
- 2. How will I be notified of my payment information? Once your agreement for tuition payments is posted to the FACTS system you will receive a confirmation notification of your payment amount by e-mail or letter in approximately IO days. Payments will be processed until the total balance is paid in full.
- 3. What happens if FACTS attempts to process my payment and there are not enough funds in my account? Should an automatic bank payment or credit card payment be returned, a \$30 FACTS Returned Payment Fee will be automatically assessed to your account for each failed payment attempt. This is in addition to any penalty your bank or the school may assess. You will be notified by FACTS of the returned payment via mail or e-mail. For payment scheduled for the  $5^{th}$  of the month, a re-attempt will occur on the  $20^{th}$ ; for payment scheduled for the  $20^{th}$ , a re-attempt will occur on the  $5^{th}$  of the following month.
- **4.** Where would I expect to see other charges like, campus store purchases, travel, etc.? Communication will follow your enrollment that will describe how the debit account will be used.
